Ethics training for all members of City Boards and Commissions is <u>mandatory</u> (Ordinance Code, section 50.109). To satisfy the requirement, the Ethics Office offers bi-monthly ethics training for all boards and commission members. Every board and commission member in the City should attend at least one these training sessions in-person every four years.

If you have not yet met your initial training requirement, or if it is time to renew (every 4 years), you are invited to join us.
